Delivery

- All bulk products are supplied on an EXW basis and delivery charges are confirmed at the time of placing an order

- Storage of product – provided the stock is called-off within a reasonable time frame – normally 3-6 months. Thereafter a fee of £4.20 will be charged per pallet per week, or part of week.

Contract Storage and Receipt, Handling & Despatch (RH&D)

- Storage – ingredients supplied by customers prior to blending, cutting and processing £4.20 per pallet per week, or part of week
- RH&D £4 per pallet, plus delivery
- Delivery As priced by our pallet freight provider, or customer collection

Analysis and testing

As part of Organic Herb Trading's Quality Management system we routinely undertake a range of analysis on our products, using a risk based system, for the list outlined below. Where customers require additional testing, or testing of their stock, the following charges apply:

• Microbiological testing	£37.50 per test
• Pesticide testing	£135 per test
• Heavy metal testing	£100 per test
• Aflatoxin testing	£90 per test
• Ochratoxin testing	£80 per test
• Volatile oil and essential oil component analysis	£45 per test
• Gluten testing	£95 per test
• Nutritional value (basic) testing	£110 per test
• Marker compound testing	Variable according to test required
• Polycyclic aromatic hydrocarbon testing	£140 per test
• Pyrrolizidine alkaloid testing	£135 per test
